The facility is for US\$474,000 to cover the Yerbas Buenas tenement acquisition payments and may be extended to meet further working capital needs of the Company. It is currently drawn to US\$306,730, after conversion during the quarter and is committed for a further US\$180,000. The loan is to be secured over the Company's interest in the Yerbas Buenas Leases following their acquisition.</p>
